IN FY20, DEDICATED VOLUNTEERS TRAVELED ACROSS THE CITY TO DELIVER OVER 1,137,000 HOT MEALS AND ALSO PROVIDED DAILY SAFETY CHECKS AND OPPORTUNITIES FOR SOCIALIZATION. VOLUNTEERS OFFERED ADDITIONAL SOCIALIZATION AND FRIENDSHIP TO 78 CLIENTS THROUGH THE FRIENDLY VISITOR PROGRAM, AND THE ANIMEALS' VOLUNTEERS DELIVERED OVER 20,000 POUNDS OF PET FOOD TO 367 SENIORS WHO WOULD OTHERWISE RISK THEIR OWN HEALTH TO SHARE THEIR MEALS WITH THEIR ANIMAL COMPANIONS.
